## Ward 5 Day! August 26, 2023

On Saturday, August 26, neighbors from across Ward 5 came together to bring back a tradition from the days of Harry Thomas, Sr. – Ward 5 Day! Inside Turkey Thicket, we had more than 40 exhibitors connecting residents to a range of organizations and resources – from health services at MedStar, to education advocates at PAVE DC, to art and wellness at Made With Love DC, to an

exercise demo class with Bikram Yoga Works Ivy City, impromptu chess matches with the DC Chess Federation, and many more. Costco and Aurora Market provided snacking

samples, and of course we had a VIP room for seniors with food provided by Ivy City Smokehouse. Outside, Woodridge Warriors played an exhibition softball game while children jumped in moon bounces, the Blacc Print Experience brought the go-go crank, DC Water provided a cooling station, and neighbors got to experience a *Taste of Ward 5* with samples from local



favorites like DCity Smokehouse and Ledo Pizza. The Ward 5 Education Equity Committee also held their 4<sup>th</sup> annual Back-to-School supplies giveaway, so students and families were able to stock up before DC Public Schools started the fall semester on August 28.

That evening, it was a packed house at Trinity Washington University for the first-ever Ward 5 Awards. I was honored to have the opportunity to recognize remarkable members of our community, nominated and chosen by Ward 5 neighbors. Several seniors were recognized, including Joe Bowser, winner of the Legacy Award, as well as neighbors Timothy Thomas and Bob King, who have invested in our Ward 5 communities for decades. Congratulations to these wonderful Ward 5 residents!







## **Constituent Services**

So far this year, my Constituent Services Coordinators have processed over 1,000 requests, assisting residents with a variety of concerns, including trash pick-up, tree pruning, assistance with utility bills, traffic safety requests, parking enforcement, and more. In April, there was a **2 alarm fire** in Fort Lincoln at The Petersburg building in the 3200 block of Fort Lincoln Dr NE. My team was on the scene with Fire & EMS, HSEMA (Homeland Security and Emergency Management Agency), and the building management to support the needs of 19 displaced residents.

In May, I was delighted to continue the tradition of hosting a Mother's Day Brunch at 3400 Banneker Dr NE, organized with Ms. Doris Foreman. It was a beautiful time celebrating the moms and mother figures that raised us, guided us, and poured into our lives. The month of May also brought a boil advisory from DC Water following a water main break and loss of water pressure in the area. My Constituent Services Coordinators worked with HSEMA to

deliver packages of bottled water to several senior buildings in the area to ensure neighbors had clean water to drink and cook with for the 3 days the advisory was in place. And of course, we've had several opportunities to

# **Budget and Legislation**

## Ward 5 Budget Wins

In early February, I hosted a Budget Forum at Woodridge Library for neighbors to come and share their budget priorities with my office. We also collected feedback through an online survey. This helped shape the budget letter I sent to Mayor Bowser in mid-February, emphasizing Ward 5 priorities including reducing poverty; improving Ward 5 infrastructure including roads, recreation centers, schools, and transit; violence prevention and community safety through expanded behavioral health services and violence interruption programs; and housing and rental assistance for District residents, to name a few. For seniors specifically, I requested that the Mayor:

- **fund laws improving senior nutrition programs and outreach** (including the No Senior Hungry Omnibus Amendment Act of 2022, and the Senior Nutrition, Health, and Well-Being Equity Act of 2022),
- expand recreational programming for seniors at Department of Parks and Recreation (DPR) facilities, and
- **explore easing property taxes for seniors**, so that neighbors have the option to age in place.

Unfortunately, the Mayor's budget did not fund these requests, and my Council colleagues were unable to work together to support these investments despite my efforts. However, we did add a \$250,000 one-time investment to the Department of Aging and Community Living to support programming that helps individuals with Alzheimer's disease maintain their bills and financial stability.

We also secured many other significant wins for Ward 5 in the final Fiscal Year 2024 budget that the Council passed in June. These include:

- Targeted investments in community safety (\$200,000 for security and cameras at Edgewood Terrace, \$200,000 for a substance abuse and behavioral health targeted outreach pilot along Mt Olivet Rd NE in Trinidad, and more).
- Traffic safety improvements (\$1 million for improvements to South Dakota Ave NE, fully funding the Arboretum Bridge and Trail, New York Ave Streetscape project, and other major arterial projects).
- Major investments in schools, libraries, recreation centers, and programs (including \$24.7 million for the Langdon Community Center redevelopment, \$15 million for the new community center at Crummell School, and \$24.7 million for a new Ward 5 library in Edgewood/Eckington).



These are just a few of the many investments the Council made through the budget process this year. ## Legislation

Since taking office in January, I have introduced, co-introduced, and co-sponsored several pieces of legislation. Here is a brief overview of the major pieces of legislation I've introduced:

- The District Child Tax Credit Amendment Act of 2023. This bill would provide an up to \$500 per child (up to 3 children) tax credit to low-and-middle-income individuals.
- The Financial Support for Families with Children Amendment Act of 2023. This bill would provide individuals earning \$10,000 or less (or joint earners making up to \$20,000) a cash payment equivalent to \$1,000 per child annually.
- The Establishment of Reasonable Controls for the Firearm Industry
   Amendment Act of 2023. This bill would empower the Office of the Attorney
   General (OAG) and District residents to sue for harms caused by a firearm
   industry members' failure to take reasonable precautions regarding the
   manufacturing, marketing, and sale of their products.
- School Safety Enhancement Amendment Act of 2023. The goal of this bill is to enhance school safety and deliver what school leaders have long asked for: new resources to prevent and respond to school safety incidents.
- Ward 5 Black History Street Designation Acts of 2023. This series of bills aims to designate streets throughout Ward 5 in honor of prominent Black figures with ties to the Ward. These individuals include: Sterling A. Brown, Julius Hobson, Sr., William R. Spaulding, Dorothy Celeste Boulding Ferebee, Edna Brown Coleman, Alexander Crummell, Elder Lee, and Rayford Logan.

I've also co-introduced legislation on a range of issues. Recently, I co-introduced a bill to help improve the District's 911 call center, the Office of Unified Communications (OUC), in the legislation **Office of Unified Communications Transparency and Accuracy Amendment Act of 2023**. This bill requires OUC to regularly share data about errors and failures in responding to 911 calls so that we can improve the efficacy of this critical agency.


## Resources
